Chair Bieganski, Trustees, and Members of the Search Committee:

In the 30 years that have passed since I last hiked, fished, and golfed in, around and through Nebraska as a nearby resident of South Dakota, I have been almost continuously engaged in accruing and applying a personal and global understanding of national higher education trends, challenges, and policy issues. Today as a public college president who has served in a variety of state systems including an emerging Research I university, a regional comprehensive university, and a pair of multi-campus community colleges, I am pleased and encouraged to apply for the position of Chancellor of the Nebraska State College System and would welcome the opportunity to explore and discuss my credentials, experience, and vision with you. When I reviewed the Search Prospectus with the consulting team, I was immediately engaged by how closely aligned the Duties and Responsibilities; Leadership Agenda; and Characteristics and Qualifications of the next chancellor are with my current and previous work; as such, I would like to address several of them briefly and collectively in support of my attached curriculum vitae.

Works to create a compelling vision for the future of the NSCS that aligns with the mission of the System and the colleges; Willingness to listen to the various stakeholders, identify problems and engage in complex problem solving; Increase awareness and market distinctiveness of the system.

Living most of my life in the upper Midwest, I directly benefited from the public school teachers and coaches who taught me—many of whom I discovered were prepared through your college system. Since that time, my career has largely been one which has created partnerships that bridge all sectors of higher education; embraced face-to-face, pure online, and hybrid course delivery modes; engaged me as a reviewer for prior learning and competency-based education methodologies; and tested my leadership in developing the first-of-its-kind US Department of Education experiment in providing Title IV funding to students of an alternative higher education provider linked to a regionally accredited one. I am keenly aware of and constantly immersed in our evolving landscape and engaged daily in dialogues with diverse audiences on subjects ranging from gainful employment to performance-based funding to consumer confidence to reauthorization of the Higher Education Act. The three major priorities and associated goals of the NSCS Strategic Plan fit squarely with my experience and passion alike, and I would be honored and energized to be the chief storyteller, persuader, and champion of the System's work.

Demonstrated success with public budgetary and fiscal management; Strengthen fiscal, environmental, technological and physical resources; Ensure financial accountability.

My prior experience includes institutions with a mix of funding streams (e.g. taxes, tuition, grants, auxiliary, philanthropic), significant financial challenges, stagnant budgets, and substantial surpluses. For each to survive or become resilient required inclusive strategic educational and facilities master planning that aligned with institutional mission, governing board priorities, and specific goals which were time-constrained, reasonable, and could be accurately measured in order to assure accuracy and accountability. When faced early in my current presidency with \$750,000 budget cut, I shared the news early with the college and established a regular rhythm and communications approach for seeking input, providing updates,

and ultimately conveying how we would balance the budget. In the process, we shed light on some areas where we could be more efficient, reallocate, or eliminate unnecessary spending that we would not have discovered if the cabinet alone had attempted to find a solution. Over time we were able to restore much of the lost funding without risking instructional or institutional integrity or cutting core services.

Serves as the channel of communication between the Board and all NSCS administrative officers and personnel, including presidents; Effective writing and public communication skills.

I am equally comfortable in the board room, classroom, civic center, or patio listening, communicating and facilitating a shared vision, strategy and successful outcomes for and with my institution. It all starts and ends with the people. My practice of gathering the right people in the same space at the same time builds consensus, resists complacency, encourages mutual understanding of the need to consider change, and ensures our inclusive discourse leads to decisive action and accountability. It is tangible in our campus master planning and in the many ways that we appear by name in the strategic plans of our region's cities, economic development offices, and other major stakeholders to our vitality and resilience.

Understanding of state government and legislative operations; Evidence of collaboration with other educational institutions, private entities and public officials and agencies; Create a diverse community.

My career is focused on educational access and attainment, community engagement, diversity and inclusion, and resource development. Every day I get to serve others in transforming lives and communities for the better—and all at a time when our graduates must not only be work ready but also <u>world</u> ready. In my current position, for example, I am accountable for leading the largest scale-up of early college high schools in the country, bringing higher education and hope to an additional 3,000 public school students just this year in a partnership that sustainably links multiple public school districts, public and private higher education, the state legislature, employer partners, and community agencies in a shared pursuit of reducing income disparity and increasing attainment by removing barriers such as cost, transportation, and time-to-degree.

Academic credentials that will inspire the respect and confidence of the academic community; History of executive leadership, preferably from higher education.

As detailed in my CV, since earning my doctoral degree, I have held fulltime faculty and student services roles along with a variety of progressively more accountable administrative positions, including my current position as president of a public community college—a Hispanic Serving Institution which during my tenure secured its first-ever USDE Title V grant to support equitable academic attainment through redesign of academic support services and online learning. My personal commitment to diversity and inclusion aligns with my active advising and mentoring within the American Council on Education's Spectrum Aspiring Leaders Program for diversifying higher education leadership at all ranks, especially senior.

Directs the management and administration of the System Office and three state colleges of the NSCS; Serves as the primary link between the Board's responsibilities for policy and the presidents' responsibilities for operations; Experience working with governing boards and implementing strategic plans on their behalf.

In my experience, when an entity like the NSCS hires and onboards well and provides sustainable support for additional learning and professional development, the chancellor and the board should be able to entrust operations to those who directly support the membership or support those who do, provided that everyone is well-informed and updated on the outcomes and impact of their work. We achieve these shared outcomes through an abundance of respect, transparency, clear communication, and inclusion. The magnitude of any

decision I make seems less so when I can with integrity say that I have looked at the situation through and with a variety of perspectives, consulted appropriately and in a timely manner, and can wholly own the decision with the personal accountability expected of the president. In all settings I have consistently practiced regular, transparent communication in keeping board members and those I supervise apprised of but not surprised by institutional actions and outcomes. In addition, I have myself served on the governing board of a university as it went through a significant transition in senior leadership and board development.

Serves as the official representative of the Board and the colleges it governs to the legislature, to the Governor, and to other governmental entities. Promotes a statewide perspective on higher education that attends to the current and developing needs of the State.

I stay continuously current in my field through attending meetings and providing service to organizations such as the American Council on Education, American Association of Community Colleges, and the Texas Higher Education Coordinating Board; liaising with regional and programmatic accrediting bodies; chairing the forenamed North Texas Community College Consortium; and reviewing proposed legislation and policy for my current system's governmental and external affairs division. In addition, I am frequently called upon to consult, craft, and advocate for state and national education policy, especially as it relates to access, attainment, and affordability. In each instance, I make it a practice to share the insights, information, and learning that I accrue with my team and other audiences that might benefit actuate it. The institution will always be infinitely bigger than the office of the president, and the office much bigger than the holder, but I am cognizant of the intertwining of all three and always attempt to represent and "wear the office" honorably and with humility as I meet with individuals of varying viewpoints, politics, and belief systems.

Promote collaboration within the system; Create a college experience that enriches the lives of our students and prepares them for their chosen careers; Secure public and private funding sources.

I spend much of my day (and the better part of many evenings) engaged in creating mutually beneficial, college, community, and corporate connections. In designing and developing early college high schools with the Dallas Independent School District, for example, we initially engaged hundreds of students and their families in seeing themselves as college-bound before subsequently supporting their success to graduation and transfer to other colleges nationwide—all the while preserving their ability to accept grants and other forms of aid to complete their education with over a dozen senior institution partners representing four different public university systems. So far, we have also secured over 60 business and industry partners who are invested in this initiative, realizing the regional educational and economic transformation it will bring.

In summary, over the course of my career, by assembling and being a stakeholder on committed teams with a common vision, I believe that I have accrued a rich combination of administrative and academic pursuits, experiences, successes, and the ability to work inclusively and collegially under constant pressure and deadlines that I feel make me a qualified candidate for the next chancellor of Nebraska State College System. I would welcome the opportunity to return in service to the region where I learned, spent summers on a farm, and in so many ways grew up. I hope we will soon have the opportunity to explore that possibility together.

### Members of the Search Committee:

Please accept my letter of application and attached materials for the next Chancellor of the Nebraska State College System. Your mission of accessibility for all students and the critical role each campus plays in its region is important to Nebraska now more than ever. I have dedicated myself to higher education and public service, and I will bring a depth of experience in both academia and government to the role of Chancellor. In addition to my professional experience, my ability to advocate effectively and implement bold plans will advance the critical mission of the Nebraska State College System.

The accompanying curriculum vitae details the specifics of my professional career. The common thread among all of my roles--state senator, undergraduate professor, large animal veterinarian, and rancher--is pursuing big ideas with dogged determination. I rely on evidence in decision making and believe in informed action over inertia.

I will bring first hand experience in government to the Nebraska State College System. While representing District 38 in the Unicameral for the last four years, I served on the Appropriations Committee. In 2017 I was elected unanimously to be Vice Chair of the Executive Board, and also serve as Chair of the Legislative Performance Audit Committee, Chair of the Legislature Safety Committee, and Vice Chair of the Referencing Board. I also serve on the Rules Committee and the Committee on Committees.

As Vice Chair of the Executive Board I gained experience in the management of a state agency, the Legislative Council. The Legislative Council oversees senators, legislative divisions, and legislative staff. My time on the Legislative Performance Audit Committee, including the past two years as chair, has enhanced my ability to evaluate policy, review statutes, and avoid the operational mistakes of many state agencies.

Prior to my legislative term I served on the Board of Directors of Southern Public Power District. Southern is the largest rural public power district in Nebraska's unique publicly owned electrical system. As a member of the board, I balanced setting multiple public utility rates with competing interests of an operational budget, an aggressive capital construction budget, long-term wholesale power purchase contracts, and issuing public bonds. We also negotiated salary and employment with unionized lineworkers, non-union support staff, and an executive management team.

My academic career at Hastings College began in August of 2000 when I was recruited as an Adjunct Instructor of Biology, teaching an Anatomy and Physiology class in addition to my full time veterinary practice. In 2004 I transitioned to a tenure-track position as an Assistant Professor of Biology, with subsequent promotions to Associate Professor in 2009 and Professor in 2014. I was awarded tenure in 2010 by the Hastings College Board of Trustees.

During my 18 years at Hastings College, I co-founded of the Student Research Initiative in Biology, served as Chair of the Personalized Program, was elected Science Division Chair, and served on numerous faculty and search committees. My work has been honored by the Vodrak Outstanding Academic Advisor Award, Student Alumni Association Polished Apple Award, and the campus nominee for CASE Nebraska Professor of the Year.

For faculty and students alike, I have lived life very similar to what they experience every day on their campus. That perspective will benefit all stakeholders in the Nebraska State College System. For students enrolled at one of the Nebraska state colleges, I bring to the office of the Chancellor my own experience as a college student from a farm community at a small, primarily undergraduate teaching institution in rural Nebraska. For faculty and staff, I have spent 14 academic years in the classroom teaching a 27 hour annual course load, all while advising dozens of students, serving on faculty committees, and being active in my discipline. I would step into the Chancellor position directly out of a fall semester in which I am in the classroom teaching a 15 semester-hour course load.

Teaching institutions create a learning community focused on student success. The students in today's classrooms in Chadron, Peru, and Wayne will be the entrepreneurs, teachers, and leaders in those same communities tomorrow. Faculty invest in the holistic development of each student as mentors and teachers. As an undergraduate, I was the beneficiary of that community. As a faculty member, I am able to equip my students for success. As Chancellor, I am dedicated to promoting that experience for every student and empowering faculty and staff to create that sense of community.

The Nebraska State College System could face many difficult fiscal and operational decisions in the coming years. The higher education landscape is changing nationwide. Increasing competition for state revenue among public priorities in Nebraska, including health care, public assistance, K-12 education, corrections, and property tax reform, as well as competition from other public higher education interests, will apply continued pressure on the state appropriation for the NSCS. My experience on the Appropriations Committee uniquely equips me to advocate for the Nebraska State College System. The NSCS needs to have a seat at the table to effectively meets its mission of access to higher education, specifically its service to first generation and non-traditional students.

In the Unicameral I gained a thorough understanding of the state budget and the budget process that can only be obtained through service on the Appropriations Committee. I take a

conservative approach to fiscal issues including the judicious use of reserve funds and the importance of transparency and accountability.

Leadership is easy when revenues are high and programs are flush with cash. Scarce resources necessitate setting clear priorities, looking for efficiencies, and making tough decisions. Being one of the nine members of the Appropriations Committee during the past two years while state revenues came in below the revenue forecast month after month required many tough decisions. Each available option had short-term and long-term implications for individuals, programs, and taxpayers. None of the budget decisions we made were easy. They were, however, necessary.

During my time as a legislator I was selected for three of the most competitive leadership development programs in the nation. These include the State Legislative Leadership Foundation's Emerging Leaders Program at the world-renown Darden School of Business at the University of Virginia, the Bowhay Institute for Legislative Leadership Development (BILLD) program at the La Follette School of Public Affairs at the University of Wisconsin-Madison, and the Toll Fellowship Program of the Council Of State Governments, the national leadership fellowship for all three branches of state government. Each of these comprehensive experiences has provided professional training in skills critical for effective leadership to augment my legislative leadership experience, including coalition building, crisis management, team development, and self-awareness.

Using these skills, I will work with each campus and trustee to meet the challenges and maximize the opportunities facing the Nebraska State College System. Making progress toward solutions, more than merely identifying problems, is what we can accomplish together. The executive staff and lobby team of the Nebraska State College System have seen first hand my approach to collaboration this past legislative session. It was my pleasure to collaborate on the approach to the Appropriations Committee hearing for the NSCS budget. The development of the volume containing letters of support from community leaders and students represents my approach to inclusive engagement of all stakeholders in ownership of the future of Nebraska's state colleges. To advance the vital NSCS mission of access we must tell that story.

I look forward to continuing to raise the profile of the Nebraska State College System among members of the Legislature, the Executive Branch, with regional stakeholders, and among all prospective students looking for affordable access to higher education. I welcome the opportunity to work with trustees, administrators, faculty, staff, students, and alumni to chart a bold course for the future of the Nebraska State College System.

I read with great interest the announcement for the position of Chancellor of the Nebraska State College System. I have more than 25 years of experience in higher education, including ten years as a tenured professor and highly-respected historian and the past nine years as the chief academic officer for the state of Missouri. I possess a highly-developed set of skills, abilities, and experience that define me as an inclusive and collaborative leader, one that can act creatively and boldly. I have a proven record of astute leadership in public policy development, a deep-rooted understanding of and appreciation for the freedoms, responsibilities, and independence of the academy, and a thorough understanding of the forces and issues shaping the topography of higher education. In short, I believe I am the forward-thinking, imaginative, and inspiring leader the Board is seeking to strengthen the system's financial position, enhance its academic excellence, and make its institutions the "first choice" for more Nebraskans. Please accept this letter and the attached documents as my application for the position of Chancellor for the Nebraska State College System.

I am eager to accept the professional challenges—of which there are many—this opportunity presents. Higher education is at a crossroads. It has been, and will continue to be, transformed by the information revolution, yet it has not fully come to terms with the knowledge-based, twenty-first century world the revolution has created. As is the case across the country, the Nebraska State College System must address decreases in state support and declining enrollment, seek new and stable revenue streams, and continue to demonstrate higher education's value amid increased demands for greater institutional accountability. These are formidable challenges, made more daunting as many people question the very purpose and value of a college degree. I am prepared to take on those challenges as Chancellor of the NSCS. My work has always been driven by an unflagging belief that higher education is both a private benefit that provides personal enrichment and growth, and a public good, vital to economic stimulation, civic participation, and improving the human condition. In many respects this is most critical issue confronting higher education today. We in higher education must recommit ourselves to the core public purposes of service and developing the whole person as we transform how our programs—for both traditional and non-traditional learners—serve the myriad and ever-changing educational needs of a knowledge-based society. We must reexamine continually what we do and how we do it or run the risk of becoming obsolete and irrelevant. Introspection does not require discarding the core values on which the academy was founded, values deeply rooted in the arts, humanities, and sciences. Indeed, only by embracing these values and redefining them for the modern economy can higher education, in my view, remain viable and relevant.

We can—and must—do more to help all citizens reach their full potential. Access to education has never been greater, but access alone is not enough. We must also work to provide all students the opportunity to pursue their educational goals at an institution that meets their needs and is affordable. We must find new ways to meet the needs of adult learners, including those who are veterans, full-time

workers, and the place-bound. It is imperative that we reduce and eliminate the achievement gap for underserved populations. The approach must be holistic, modeled on cross-sector collaboration but also by building on the opportunities the state college system offers.

The task is daunting but with a confident and discerning leader—and its continued commitment to unity of purpose—the Nebraska State College System is well-positioned to fulfill its vision of being a model of collaborative educational excellence; I believe I am that leader. Former Missouri Commissioner of Higher Education David R. Russell, for whom I worked for six years, has described me as a "highly effective thought leader . . . notable for selflessness, inclusiveness, collegiality and intellectual ferocity." Russell singled out my ability to forge effective collaborative relationships among the state's institutions (what he calls a "blend of directness and diplomacy") as driving higher education reform in Missouri. Navigating the complex political environment to achieve real results requires cultivating professional relationships with people from a wide range of backgrounds, a skill that is perhaps my greatest strength. I have worked closely and regularly with presidents, provosts, and faculty, as well as with elected officials and senior leaders in the private and civic sectors. My work in the political arena has included drafting legislation to advance the state's higher education agenda and testifying before legislative committees. Given the potential impact for the department and the state, my participation in decision and policymaking demands great sensitivity, tact, and political astuteness. In all of my work, I take pride in my ability to see and understand issues from multiple perspectives. I derive great professional satisfaction in bringing people together to work toward a common goal while helping them navigate through competing interests.

I have led most of the department's major initiatives designed to keep higher education in Missouri accessible, affordable, and effective. For example, twice (in 2011 and 2017) I led a statewide review of all academic programs, resulting in hundreds of low-producing or marginal programs being deleted. I directed the Missouri Reverse Transfer Initiative by convening competing stakeholders from community colleges and universities—both public and private—in pursuit of the common goal of improving student outcomes and completion rates. Since 2014, nearly 1,000 students have received degrees through the initiative. Under my leadership, we have reformed remedial education in Missouri with striking results: the remediation rate statewide has dropped by 36 percent since 2012. We have also implemented Math Pathways statewide, which promises to further drop the remediation rate and improve mathematics education in Missouri. Perhaps the greatest test of my leadership has been the on-going development and implementation of CORE 42, the Missouri Core Transfer Curriculum. We met the statutorily-mandated deadline of January 1, 2018, only through frequent—and at times contentious—discussions to reconcile the conflicting objectives of community colleges and universities. What we've produced will, I believe, greatly improve credit transfer for students (reducing both cost and time to degree) while also allowing institutions to retain autonomy over their own curriculum.

As a key member of the Commissioner's Senior Staff I engage in nearly all department functions, including budgeting, performance funding, personnel policies and decisions, financial aid, and government relations, among others. In 2015 I led the department's efforts in developing the state's strategic plan for higher education by chairing workgroups, planning "listening sessions" across the state, and drafting the final document. I help plan and contribute to annual board development retreats and a statewide Governing Board Forum, which convenes representatives from governing boards across Missouri to discuss common issues and concerns. As you can see from my resume, throughout my career I have given numerous presentations to a wide range of audiences. Given this experience and my effectiveness as a communicator, I would be an effective advocate and public face for the system.

I have the breadth and depth of skills and experience to manage the system office and coordinate Board activities. My duties as head of the Academic Affairs unit, combined with my previous

experience in private business, has given me broad-based experience in all aspects of managing an organization. In addition to overseeing the budget for Academic Affairs, I supervise a \$1.78 million grant from the U.S. Department of Education, and have secured and managed an additional \$800,000 in external grant funding. During my tenure at the MDHE, I have demonstrated my skills in nurturing the professional growth of my staff through collaboration and mentoring. I believe I have been very successful in attracting and developing colleagues who are quality-minded, achievement-oriented, and committed to the mission and values of the department. I have retained key staff members for five or more years. Additionally, I have had direct responsibility for vetting and recommending candidates for Senior Staff positions.

My interest in this position stems in part from the trajectory of my career path. While working full-time to support my family. I enrolled as a first-generation college student at Washburn University, graduating in four years. From there I earned my doctorate at the University of Kansas, taught United States history at several institutions before landing at Hood College, where I received tenure. My time at Hood was enriching, as a teacher, scholar, and member of institutional governance. In the classroom, I shared my passion for learning with my students, helping them to see the liberating value of education grounded in the liberal arts and humanities. As a graduate program director I oversaw program development, student recruitment, curriculum, course scheduling, and program assessment. Under my leadership, we increased student retention and elevated the academic rigor of the program. I also immersed myself in institutional governance at a time when the college faced existential financial challenges. For example, I served on a wide range of college-wide committees charged with addressing such crucial issues as student persistence, graduation rates, residential life, academic support services, and student satisfaction, among others. I chaired the governance subcommittee-comprised of faculty, staff, students, and college trustees-for Hood's regional accreditation self-study. I created a plan for addressing our charge (assessing Hood's leadership, governance, and administration) and had primary responsibility for compiling our work into a report for the steering committee. My somewhat unconventional career path has given me an abiding respect and passion for education. I deeply appreciate the challenges all students face and how critical it is for us who work in higher education to serve their needs. These experiences—in combination with my nine years at the MDHE—solidified my belief that success and stability in higher education largely dependent on building and nurturing a culture focused on student growth, development, retention, and success.

I am an imaginative leader, a supportive team player and builder, and a dynamic communicator and effective listener with a proven record of building strong collaborative relationships. I have been and will continue to be a passionate and relentless advocate for higher education. I am excited about the possibility of becoming the Chancellor for the Nebraska State College System. The issue is not whether Legislators or stakeholders value the work done by postsecondary institutions to accomplish these goals; rather the challenge confronting the next Chancellor is how to effectively work with the executive and legislative branches to make higher education a higher priority for state funding and support. To achieve this, it is imperative to focus efforts away from polarizing issues that shape the debate about higher education, and convince constituents that higher education warrants critical investments during the next decade.

#### **Leadership for Positive Change**

I have a record of successfully driving systemic change within the higher education system in South Dakota, attributable in part to my collaborative approach to leadership. Some key examples of policy initiatives having a positive impact on student persistence and completion under my leadership include reducing the total credit hours needed for a bachelor's degree in the system from 128 to 120, re-designing remedial education, and implementing a statewide early-alert system. I have organized these and other initiatives using a shared governance approach where campus administrators, faculty, and staff engage to achieve goals for increasing both access and degree attainment without adversely impacting quality. My open and transparent approach has been influential in articulating a vision for the system, including working with institutional leadership to implement that vision in the areas of student success, achieving efficiencies, and expanding research growth at our institutions. Regardless of the constituent group, I take a cooperative approach to emphasize how a unified strategy to postsecondary education can have a profound impact on efficiency and ensuring that students have a valuable postsecondary experience. I feel a strong sense of accomplishment for my role in achieving positive outcomes for higher education in the state. These include securing special appropriations from the legislature, maintaining and expanding our various research and scholarship programs, and developing innovative initiatives that facilitate student success. Specifically, I would like to highlight three projects that demonstrate my ability to provide leadership to initiatives through engagement with institutional stakeholders around a common student-centered vision.

First, Boards have the opportunity to ignite exigencies necessary to facilitate comprehensive change on campus that may be difficult for institutional presidents to manage on their own. For example, the work to redesign general education in the system resulted from a need to address a set of unique and emerging institutional challenges. In response, I chaired a General Education Redesign Taskforce representing faculty and staff from across the state system. Collectively, we identified challenges with the existing general education structure and developed strategies to evolve both institutional and system requirements. The work of the taskforce resulted in eight action items approved by the SDBOR in Spring 2016 that produced three significant changes: (1) increased

flexibility for institutional course assignments, (2) a new assessment model focused on student work rather than standardized assessments, and (3) the formation of a General Education Council charged with continuous evaluation of the curriculum to ensure students can seamlessly transition between two-year and four-year public institutions within the state. General education is one of the most central features of the curriculum in the view of many faculty. Under my guidance, our redesign process brought about the most dramatic changes for the state system in over a decade with no opposition raised to the Board when they adopted our proposed changes.

Second, student success in gateway math courses continues to emerge as a source of tension for Legislators and a factor dramatically impacting student success. A number of states have faced legislation restricting admission to remedial students at public four-year institutions. To proactively address this approach in South Dakota, I engaged the Board on its willingness to explore new pathways for students, then formed a system committee of mathematicians to evaluate alternative approaches and bring forward recommendations. The Board approved the recommendations of this committee in May 2018 for a strategic redesign of a System Math Pathway model that has the potential to dramatically improve student opportunities into the next decade. This framework allowed for the development for a truly system-level budget request for the necessary student support services to increase the effectiveness of the model.

Third, the state system in South Dakota routinely received criticism for a lack of nimbleness in the creation and development of new degree programs aligning with state industry and workforce needs. Institutional presidents reinforced this criticism by noting the need for speedier processes for approving curriculum and programs through the SDBOR central office. To address this issue, I identified comprehensive changes to incorporate into SDBOR policy to manage routine curriculum requests and move program requests along more quickly to the Board. In the four years prior to my assuming the Chief Academic Affairs Officer position, the Board approved a total of 139 program requests; during the past four years, this number has increased to 204 resulting in a 47% increase.

## **Commitment to Student Success and Planning**

The specific initiatives referenced above are just a few examples of numerous projects and activities that I have managed during the past twelve years. A common element of each is the goal of improving student success opportunities. I am confident that my experience with these initiatives has prepared me well to serve the Nebraska State College System as its next Chancellor who will be instrumental in guiding the efforts to achieve the three strategic priorities for the system. These priorities for enhancing educational excellence, maintaining fiscal strength and stability, and fostering system prominence align closely with a number of metrics that the Board and the three institutional Presidents use to measure success. I worked closely with the SDBOR to develop their current strategic plan, and have primary oversight for tracking trends on the twenty metrics we used to assess our policy goals in South Dakota. Additionally, much of my work with South Dakota's campuses seeks to advance strategies for moving the system forward in meeting our goals for higher education by 2020. As the Nebraska State College System looks toward the future and begins to set new priorities and strategic vision, the system must engage institutional leaders in difficult conversations about how to further improve academic quality, promote student success, and maintain affordability for the students they serve. The right Chancellor can help the Board as it advocates for legitimate and meaningful change by facilitating dialogue and creating valuable momentum points. I am confident that I have the necessary skills to engage the Nebraska State College System in this important task.

My experience with institutional research demonstrates a strategic approach to problem solving that utilizes complex information to set priorities for timely and sound decision making. Data are

essential to evaluating institutional initiatives, targeting areas of improvement, and framing priorities; using data ultimately leads to more informed policy decisions. This background has also instilled an innate interest in using all forms of data in innovative and imaginative ways to move strategic initiatives forward. One of the projects that I managed was the creation of Interactive Dashboards using system and national data to improve decision making by campuses and stakeholders. I directed the development of 17 dashboards around themes of access and enrollment, graduates and placement, institutional analysis, academic policies, and the state labor force, to allow broader access to various institutional, state and national data. These interactive tools have been influential in empowering campuses to explore data on in-state matriculation, student persistence and success, and placement, to improve campus-level completion agendas. Just as important, these dashboards demonstrate to Legislators and policymakers a desire to improve transparency within our system.

In closing, higher education in Nebraska, and across the country, will face numerous challenges in the coming decade. These challenges will require visionary leadership to assist institutions as they continually evolve to serve new student populations, better align degree offerings, and identify opportunities for higher levels of collaboration. The Nebraska State College System has benefited from a stable and effective Chancellor tasked with developing and maintaining the collegiality that is necessary across your three institutions. I firmly believe that I am ready for this challenge, as my administrative and educational experiences have prepared me to provide stable and visionary leadership as the next Chancellor for the Nebraska State College System. This experience can be influential in making an immediate impact for advancing the goals of the Board, and further solidify its position in the state and across the region. To date, my career path has taken me from South Dakota to Lincoln, NE and back home to Pierre as I have treasured the upper Midwest culture that values an engaged community, cooperation, and a strong work ethic. While each state has its own unique dynamics, my administrative background and knowledge of the people and issues in the upper Midwest region can make an immediate, positive impact for the Nebraska State College System. Thank you in advance for considering my materials for this position, and I hope to have an opportunity to discuss my qualifications with the Search Committee in the future.

## Administrative Experience/Responsibilities

## System Vice President for Academic Affairs – 2014 - Present

As the System Vice President for Academic Affairs, I provide leadership for the academic and research functions of the South Dakota Regental system. This is accomplished through management of the Academic Affairs Council, which is tasked with managing system initiatives targeted at improving student preparation, progression, and completion through efforts to improve time to degree, increase affordability, and foster collaborate programs. This position provides direct supervision over six areas in the Regental system with supervisory authority over *Research and Economic Development*, *Institutional Research*, *State Scholarship Programs*, *New Program Approval*, *the Regental Library Consortium*, and *Instructional Technology*. Specific duties and responsibilities include the following:

- Manage the Academic Affairs Council, which includes the Provosts and Vice Presidents for Academic Affairs across the six Regental campuses. The Academic Affairs Council works collaboratively to develop common strategies for eliminating barriers that adversely impact student success across the Regental system and the state. This includes oversight of recent redesign of the System General Education requirements, development of unified placement policies, engagement in the WICHE Interstate Passport, and refined transfer of credit practices to positively improve student pathways to degree completion. These projects align closely with the state's 65% Attainment goal to increase the number of citizens with postsecondary credentials.
- Initiate the review of all new program requests and modifications (majors, minors, certificates) from the campuses beginning with the initial inception to approval by the Board of Regents. Additionally, all institutional curriculum processes (new & existing course requests and general education) are reviewed for final approval to ensure consistency within the common catalog to facilitate seamless transfer for students.
- Provide oversight for Research and Economic Development through management of the Research Affairs Council, which works to advance the grant, research, and scholarly goals in the Regental system by strengthening research infrastructure and competitiveness. This includes coordination of state level competitive research grants, Governor Research Centers, research and development grants, and efforts for expanding economic development opportunities.
- Coordinate six state scholarship programs that are administered through the Board of Regents. These programs include the Opportunity Scholarship, Dakota Corps Scholarship, Jump Start Scholarship, Critical Need Teaching Scholarship, Needs Based Grant Program, and the Veterinary Tuition Assistance program. Work closely to manage the day-to-day operation of these programs and their various scholarship boards, and engage the Legislature in the continuous refinement of these programs to meet the needs of the state.
- Oversee Institutional Research activities to provide routine and ad-hoc analyses for the Board
  of Regents, System Councils, and stakeholders. Most recently this activity has resulted in the
  creation of interactive dashboards that ensure greater transparency for Board of Regents
  strategic plan metrics, and greater access to data by the Board and stakeholders for making
  better informed policy decisions.

- Guide the Extended University Consortium representing the Continuing Education and University Center Directors in the continued expansion of programs/courses delivered off campus and via distance. This includes managing the common Quality Assurance process established for online courses, and oversight of the state High School Dual Credit and Concurrent Credit programs. Responsibility for the State Authorization Reciprocity Agreement for South Dakota through Governor's Executive Order, and ensuring compliance with the constantly evolving set of federal regulations that guide distance education. This area also includes management of the system's instructional technology resources allowing for common instances of a Learning Management Systems (D2L), early alert (Starfish), online proctoring (Respondus), and tutoring (Smarthinking) solutions.
- Coordinate the Regental Library Consortium by maintaining the common Integrated Library System and state database investments. The network includes the various deans/directors for the libraries within the system responsible for identifying ongoing efficiencies in resource allocation and staffing. Additionally, the newly formed Regental Database Consortium includes additional members from the various academic, local school, and community libraries who collaborate to share common databases for journal access. Management of these resources includes coordination of the Deans at the six Regental libraries and service on the South Dakota State Library Board.

## System Vice President for Research & Economic Development – 2012 - 2014

As the System Vice President for Research & Economic Development, I worked closely with the representatives of the system Research Affairs Council as it coordinated research and grant related initiatives and policies for the South Dakota Regental system. The position provided leadership to advance the grant, research, and scholarly goals in the Regental system by working with state government leadership, including the Governor, Executive Branch Agencies, and legislators, in making university research efforts effective for South Dakota. These responsibilities included oversight of state level competitive research grants, Governor Research Centers, research and development grants, expanding economic development opportunities, as well as the ongoing management of two areas within the Board of Regents system office: 1) *Institutional Research* and *Scholarship Program Coordination*. Specific duties and responsibilities for this position included:

- Managing the Research Affairs Council, which included the Vice Presidents for Research at the
  six Regental universities, to help strengthen system research infrastructure and competitiveness.
  This included promoting excellence in research across the system, making research a priority
  that is linked to undergraduate and graduate education. The Research Affairs Council met five
  to six times each year to coordinate common research/grant related policies and initiatives.
- Working closely with the Governor's Office of Economic Development to manage state-funded Governor Research Centers, which were located at campuses within the Regental system. This work also aligned with service as the system representative on the Research & Commercialization Council (RCC), Research Excellence: A Critical Hallmark (REACH), and South Dakota Experimental Program to Sponsor Competitive Research (EPSCoR). These councils/committees worked to further develop the state's STEM research infrastructure.
- Coordinating a number of competitive state-level grant programs that included Competitive Research Grants (\$450,000 annually), Research & Development Grants (\$1 million annually),

Governor Research Centers and South Dakota Research & Innovation Center programs (\$3.2 million annually), Title II, Part A, Improving Teacher Quality State Grants (\$300,000 annually). The System Vice President for Research & Economic Development established the RFP parameters for each program, and facilitated the review and selection process for all awards.

## Associate Vice President for Academic Affairs – 2008 - 2012

As the Associate Vice President for Academic Affairs (AVPAA), I worked closely with the representatives of the system Academic Affairs Council and Student Affairs Council to coordinate academic and student success related initiatives, policies, and guidelines for the South Dakota Regental system. These responsibilities included oversight of assessment, placement, and accountability practices, as well as the ongoing management of three areas within the Board of Regents Central office: 1) Institutional Research and Technology Integration, Scholarship Program Coordination, and leadership on a variety of Student Success Initiatives. Duties & responsibilities for this position included:

- Working closely with the System Vice President for Academic Affairs to support his work with the Academic Affairs Council, and coordinating with the Student Affairs Council, which includes the Vice Presidents for Student Affairs in the Regental system.
- Providing strategic leadership for the six state scholarship programs through work with the
  Department of Education, legislators, and/or the Governor's staff to shape these programs to
  best serve South Dakota students. This included development of the state college preparation
  portal (SelectDakota.org) which continues to provide prospective students (traditional, transfer,
  adult learners) with information they need about why and how they can move into their postsecondary experience.
- Serving as primary leader for the system's involvement in the *Non-traditional No More* grant (supported by the Lumina Foundation) and Complete College America which sought to facilitate state level policy work around the goal of increasing the degree credentials for citizens in the state. These initiative were successful in further refining developmental coursework and academic advising to improve the success of underserved student populations.
- Providing leadership in the system's efforts to collaborate with the South Dakota Department of Education and the South Dakota Department of Labor and Regulation to establish data sharing agreements. This also included oversight of the numerous institutional research activities in the system (i.e., ad-hoc and routine reporting and analysis).
- Guiding system efforts to further integrate an array of technology-based tools into the teaching and learning environment. This has included institutional programs like the mobile computing initiative, student technology fellowships, a common Learning Management System, and expansion of institutional use of software in developmental courses.
- Leading system efforts to facilitate college completion and student success initiative which has included the development of an early alert system for identifying at-risk students through use of information available in the student information system, feedback obtained from faculty, and the common learning management system.

## Director of Academic Assessment – 2006-2008

As the Director of Academic Assessment, I fulfilled a variety of assessment and institutional research roles for the Board of Regents. As the Director, I worked closely with campus representatives to facilitate system assessment, placement, and accountability related to Board policies. This also included the role as institutional researcher responsible for assisting the Chief Academic Affairs officers, Executive Director, and Academic Affairs Council in making informed policy decisions. Duties and responsibilities for this position included:

- Coordinating system-wide groups representing personnel in the areas of testing, assessment, and institutional research and facilitating projects through the Regents Information System to develop routine and ad-hoc reports for the Board of Regents.
- Managing the System Assessment Committee by providing leadership on the Collegiate Assessment of Academic Proficiency testing, National Survey of Student Engagement, Student Opinion Survey, System Placement, and other system-level survey efforts. This also included leadership pertaining to the Regental system's involvement in the Voluntary System of Accountability initiative which sought to establish a common set of metrics for measuring academic quality across institutions and states.
