I am writing to strongly recommend Dr. Christy Hutchison for Emeritus Status in accordance with the Nebraska State College System Board Policy 5017. I have known and worked alongside Dr. Hutchison for six years and found her to be an inspiring mentor to students and faculty alike, a dedicated researcher, and an engaged service advocate for Peru State College and the campus community. She is distinguished, caring, and a respected educator. The time and effort Dr. Hutchison has dedicated to this campus and community is second to none. Dr. Hutchison has been a full-time employee of Peru State College since 2004. She obtained the position of Assistant Professor in Business in 2004 on the tenured track, was promoted to Associate Professor in 2009, received tenure in 2010, and obtained the rank of Professor in 2014.

Since joining Peru State College, Dr. Hutchison has taught a variety of courses. Those courses include BUS 251 Legal Environment and Contract Law, BUS 252 Commercial Law, BUS 353 Organizational Ethics, BUS 460 Employment Law, BUS 493 Team Design and Performance, and CJUS 498 Contemporary Legal Issues at the undergraduate level. She also taught MGMT 533 – Conflict Management and Mediation at the graduate level and served as the faculty mentor on several MGMT 696/697 Research Projects. It's very evident she puts forth the time and effort necessary to effectively teach, and it's truly been a pleasure to have her as my instructor this semester." Even at the beginning of her academic journey, Dr. Hutchison received high remarks from her students. In 2004, a student from her BUS 351 Commercial Law course wrote, "I have never been so impressed with a professor before. I have never had such an awesome instructor at UNL. She graded hard but fair. I felt I earned my grade and I feel I have learned more about how the world works and how I can fit in it. WOW. Thank you, Peru and Dr. Hutchinson!" It is important that I specifically quote our students, as at Peru State College, they come first.

Dr. Hutchison's teaching evaluations remained strong throughout her tenure receiving satisfactory (the highest marks given) remarks annually. In 2020, Interim Dean Timothy Borchers, wrote, "Professor Hutchison has had another strong year as an effective teacher, scholar, and college citizen." While committed to her students, Dr. Hutchison was a faculty advisor to both Business and Pre-Law students, judged numerous contests on campus, is an active Higher Learning Commission Committee member, and active steward for the campus. Esteemed Colleagues,

I write in support of the award of Emeriti status to Dr. Christy Hutchison. I know Dr. Hutchison's service to the Nebraska College System, Peru State College, her colleagues and students to represent all values exemplary in higher education. Dr. Hutchison served Peru State College in many and varied capacities. She consistently served as role model as a leader in within the academic community and a role model for both colleagues and students.

Dr. Hutchison modeled leadership in many capacities. Her contributions to the Institute of Behavioral and Applied Management (BAM) included numerous presentations of research and leadership of round table discussions related to current topics relevant to academic freedom particularly as related to free speech in academic settings. She presented independent research at conferences and while frequently collaborating with Dr. Hutchison, I had the opportunity to recruit and nurture younger members in attendance at IBAM conferences to assume and train for future leadership roles within the organization ensuring consistency in quality leadership leading the organization into the future. Indeed, she accepted the seven-year journey required to reach the status of President of the organization.

Dr. Hutchison accepted responsibilities well beyond requirements. In addition to leading numerous committees, participating in numerous strategic planning endeavors, representing faculty in Nebraska State Education Association positions, she wrote the Higher Education Committee Report, a daunting undertaking. Dr. Hutchison always accepted difficult roles when asked completing important documentation, leading necessary change, often providing inclusive opportunities for others to participate and sometimes attending to the majority of work on her own.

Throughout her tenure at Peru State College Dr. Hutchison collaborated across the college system and collaborated across the Peru State Campus. Dr. Hutchison helped in the organization of several multicampus opportunities for faculty to present and share research. She consistently collaborated with colleagues at Peru State College for research presentations at conferences. She helped establish the "Growing Ideas" series on the Peru State College campus which honored another of our colleagues, Dr. Bill Snyder. Her use of case studies, providing students occasion to analyze, research, discuss and draw conclusions were always stimulating delivering an enriching learning experience. Indeed, she received the outstanding teacher award at Peru State College and was named the outstanding teacher in the Nebraska State College System.

Most importantly, from my perspective, Dr. Hutchinson modeled, for all those around her, what it means to be a servant leader. She modeled for students and colleagues what it means to be an integral participant in life, what it means to be a life-long learner and a contributor to society. When organizing opportunities for students to be engaged in community efforts she organized a program for volunteer students to help literacy efforts for foreign employees of a local plant. She always listened to student concerns advising how to resolve issues. She was always available to students, driving many to local communities for appointments or airports to catch flights home or inviting students to her home for holiday meals. She was particularly aware of the needs of international students serving as sponsor for an international student organization, often helping them integrate into the experience of American college student. She was available and welcoming to everyone who sought her out.

Dr. Christy Hutchison represents everything indicated by the title Emeriti; her contributions to her field, to her school, and to her students are exemplary. I have been honored to be her colleague. Dr. Hutchison has been, and always will be, a proud representative of the Nebraska State College System and Peru State College.
