ACTION:	Approve Emeritus Status for Dr. Sara Crook (AP)

Dr. Sara Crook, a faculty member from Peru State College who will retire in May 2022, has been nominated for emeritus faculty status upon the four required criteria for granting emeritus status, as outlined below:

- 1. Minimum of 15 years of full time employment is met through 38 years of teaching at Peru State College.
- 2. She earned the rank of full professor in 2002.
- 3. Evidence of exemplary performance in areas of teaching, scholarship/creative activities, and service is represented by her continued focus on engaging her students in authentic learning experiences. She served as a co-advisor to the Phi Alpha Theta honor society for students and professor of history and was founder and director of the Peru District History Day Contest. She serves as a Great Plains Fellow with a specialty in the U.S. Congress and Nebraska politics, and she organized the Unicameral Internship. She received the 2005 Barb Lewellen Award in recognition of her outstanding service to the student of Peru State and was also selected as the NSCS Teaching Excellence Award recipient in 2002.
- 4. Demonstrated leadership and collaboration through service and contribution beyond normal expectations is also reflected through her appointments by the Governor to the Nebraska Hall of Fame Commission and the Nebraska 150 Foundation, as well as serving as President of the Nebraska State Historical Society and Chair of the Nebraska Sesquicentennial Commission. Her leadership roles at the College include organizing and overseeing the Unicameral Internship and serving as Chair-Elect and Chair of Faculty Senate.

Chancellor Turman supports the nomination and PSC President Evans provided a letter of support for Dr. Crook's nomination. Both recommend that emeritus faculty status be granted.

The System Office and Peru State College recommend approval of the Emeritus Status for Dr. Sara Crook (AP).

Dr. Crook's nomination for emerita status has received support from Vice President for Academic Affairs Tim Borchers as well as from Dean Paul Hinrichs. I enthusiastically recommend that the Nebraska State College System Board of Trustees grant emerita status to Dr. Sara Crook, in recognition of her decades of impressive and meaningful contributions to Peru State College and our students.

Dear Drs. Evans and Borchers,

I am writing to nominate Dr. Sara B. Crook for Emerita status on her retirement after thirty-eight years of outstanding teaching, scholarship, and service to the Peru State College campus, surrounding communities, and the state of Nebraska. No one is more deserving of this honor.

Dr. Crook joined the faculty of Peru State College in 1984 as an adjunct faculty member while completing her doctoral work at the University of Nebraska. After earning her doctorate she was promoted to Assistant Professor of Social Science 1993, Associate Professor of Social Science in 1997, and has been a full Professor since 2002. She has published in major journals in Political Science including the American Political Science Review, the British Journal of Political Science, and the American Journal of Political Science. She has maintained professional memberships in numerous organizations, among which, the Nebraska Historical Society Foundation, Nebraska State Historical Society, Nebraska State Preservation Board, Nebraska State Historical Society's Educators Advisory Council, and the Nebraska City Historical Society.

Dr. Crook has held numerous statewide leadership, board, and trustee positions. She was appointed by the governor multiple times to serve, and continues to serve, on the Nebraska Hall of Fame Commission. In another gubernatorial appointment, Dr. Crook was elected to preside first as vice-chair and later as chair of the Nebraska Sesquicentennial Commission. She was also elected President of the Board of Trustees for the Nebraska State Historical Society and worked on the Nebraska 150 Committee in preparation for the 150th anniversary of Nebraska statehood. She also continues to serve on the board of directors for the Missouri River Basin Lewis & Clark Center.

Recognition of Dr. Crook's assiduous work and contributions to Nebraska's civic life and promotion of the humanities have also been numerous and varied. The awards and recognition she has earned over the years include "Distinguished Nebrasklander" by the Nebraskaland Foundation in 2019. She was a recipient of the Addison E. Sheldon Award for "significant achievement in the interpretation and preservation of Nebraska history," and received the National Parks Services "Network to Freedom" Award for her portrayals of Barbara Kagy Mayhew Bradway. She held the Lillian and George Schottenhamel honors Chair of Humanities from 2002-2004 and was honored as the Nebraska Humanities Speaker's Bureau Presenter in 2003. She received the Barb Lewellen Award in recognition of outstanding service to the students of Peru State College and was chosen for both the Nebraska State College System's and Peru State College's Teacher Excellence Award in 2002.

As an outstanding teacher, who taught first by example, Dr. Crook's impact on Peru State College students cannot be overstated. In addition to lectures, students in her classroom engage in real-life projects that have included the placement of state historical markers and researching and writing nominations for potential candidates to the Nebraska Hall of Fame. She took students on annual trips to the Unicameral, where they sat in on legislative sessions, and attended a variety of senate and committee hearings. They didn't just learn about how government works from their textbooks, they watched it in action. Students researched issues of their choosing and wrote to their legislators. They attended city council meetings and engaged in voter registration campaigns. In support of local humanities, freshman student assignments included visits to at least three local museums or attendance at three humanities or civic events both on and off campus.

Dr. Crook was a huge advocate of student travel to places near and far. She has taken students to Washington, D.C., Boston, Philadelphia, across Nebraska, and through the Deep South. She has encouraged students to present their scholarship at state, regional, and national professional

conferences. While there, students also visited local sites of historical import and enjoyed cultural activities. I have traveled with her when, as she drove a van full of students, she regaled them with tales of other trips she has taken, stories from history, and life lessons learned. In their own words, edited here for brevity, are some comments from current students and alumni of the Social Science program:

"I loved having Dr. Crook as a professor because she cared and had high expectations. She not only pushed us to do our best but reached out to make sure we achieved what she saw in us."

"Dr. Crook truly is a once-in-a-generation educator . . . I owe her a great debt for everything I have learned from her . . . words simply cannot fully express the deep impact she had on my time at Peru State."

"Dr. Crook was one of the best professors I ever had... she is the best of the best of the best ... truly an amazing person.

"Dr. Crook is a dedicated and outstanding educator, historian, and leader, someone whom I attempt to emulate every day in my own life and classroom."

Dr. Crook has also amassed a long record of service to Peru State College, some of which is pathbreaking. In the Social Science department, Dr. Crook founded and was the first director of the Peru District History Day Contest, a position she held for thirty-three years. Across campus she has served on every standing committee on multiple occasions, numerous ad hoc and search committees for administrators and faculty, and as faculty senate chair. As a faculty advisor she has been the backbone of the Social Science Club and the campus chapter of Phi Alpha Theta Honor Society. Dr. Crook also presided as faculty advisor to the student senate for twelve years. Her service to Peru State Students is also reflected in the words of her colleagues, again edited for brevity:

"The mark of difference-making teacher who makes an impact at Peru State College is the teacher who clearly understands that "teaching" does not start and stop at the threshold of the classroom door but instead extends itself well beyond that threshold each and every day via meaningful connections, life-changing relationships, and exemplary enhancement of the 'lived experience' of the mission of PSC within the student, colleagues, campus, community, and beyond. Dr. Crook is the embodiment of this kind of 'teaching' and represents what is the very best about Peru State College."

"Dr. Crook was a colleague, mentor, and friend during my time at PSC. She always led by example with professionalism, skills, and determination that few others could rival . . . Dr. Crook is one of the greats, who built the social science program into what it is today."

"In addition to being role model in the classroom, Dr. Crook is a role model for all faculty members – especially female faculty members. She is an exemplar of professionalism and integrity. Her mentorship of young faculty throughout her tenure at Peru State College has been invaluable in the creation of a cadre of outstanding teachers and outstanding faculty members. Dr. Crook is the embodiment of what a faculty member at a small, liberal arts college should be."

"Dr. Crook was a wonderful colleague. She was completely reliable, energetic and always interested in new activities to interest Peru's history students. Under her direction, History Day became a flourishing regional event drawing hundreds of high school students to the campus"

Dr. Crook is more than deserving of this honor. I am personally grateful for her guidance and mentoring as I began my academic career. She is deserving of every superlative noted above and has been a treasured asset to the Peru State College campus community, to her colleagues, and above all, to the thousands of students whose lives have been enriched by her teaching, mentoring, and guidance for the last thirty-eight years.
