ACTION: Approve Learning Management System Contract Addendum

Per Board Policy 7015, this Addendum for expansion of a Learning Management System (LMS)requires Board approval, because the contracted amount is over \$300,000.

This Addendum converts an existing Wayne State College Agreement with Instructure, Inc., into a System-wide services agreement that will provide the same Learning Management System platform, Canvas, to all three Colleges. This is the culmination of an extensive collaboration among the Colleges and the System Office. Faculty at Chadron State and Peru State are very supportive of the change to a common LMS.

In total, the cost of the Addendum over a five-year period is \$818,949.86. A copy of the Addendum is attached.

The System Office recommends approval of the Learning Management System Contract Addendum.

ADDENDUM NUMBER 1 TO THE AGREEMENT BETWEEN THE BOARD OF TRUSTEES OF THE NEBRASKA STATE COLLEGES AND INSTRUCTURE, INC

This Addendum Number 1, entered into and effective on April 21, 2022, modifies the Instructure Standard Terms and Conditions ("Agreement") between the Board of Trustees of the Nebraska State Colleges dba Wayne State College, ("Customer") and Instructure, Inc. ("Instructure") entered into on May 29, 2019, as follows:

- 1. Definitions: All definitions set forth in the Agreement shall have the same meaning unless stated otherwise in this Addendum.
- 2. This Addendum Number 1 changes the reference "the Board of Trustees of the Nebraska State Colleges doing business as Wayne State College" to "the Board of Trustees of the Nebraska State Colleges doing business as Chadron State College, Peru State College, and Wayne State College."
- 3. This Addendum Number 1 becomes effective on July 1, 2022.
- 4. This Addendum Number 1 is issued to define the expiration date of the Agreement as **June 30**, **2027**.
- 5. This Addendum Number 1 revises the annual fees paid to Instructure according to the attached Services Order Form #Q-247218-4 dated April 5, 2022. The original Agreement Services Order Form (#Q-76677-6) dated May 29, 2019, is hereby made null and void.
- 6. This Addendum Number 1 revises the Designated Customer Representative to Cheri Polenske, NSCS Chief Information Officer (CIO), 402-471-2505.
- 7. All other terms and conditions of the Agreement remain unchanged.
- 8. By executing this Addendum Number 1 and Services Order Form #Q-247218-4, each party agrees to be legally bound by the Instructure Terms and Conditions entered into with the Board of Trustees of the Nebraska State Colleges, originally executed on 5/29/2019, with the above noted modifications.
