## BOARD OF TRUSTEES OF THE NEBRASKA STATE COLLEGES ITEMS FOR DISCUSSION AND ACTION\ACADEMIC AND PERSONNEL

ACTION: Approve Amendment to Interlocal Agreement with Wayne Community School District for Wayne State College

Wayne State requests approval to enter into an amendment to the Interlocal Agreement with Wayne Community School District (School). Wayne State has had a long-standing Agreement with the School District to provide access to facilities with the current Agreement signed in 2018 and an amendment signed in 2021. Last year's amendment decreased the cost associated with the School District's use of Wayne State facilities due to the fact that Peterson Fine Arts would not be available over the course of the next year and other adjustments were also made to adjust use of other facilities which further reduced the cost to the School District. This Amendment #2 would extend the Agreement through August 1, 2023 at the reduced rate given that Peterson Fine Arts will continue to be unavailable during much of the next year.

The System Office and Wayne State College recommend approval of the Amendment to Interlocal Agreement with Wayne Community School District for Wayne State College.

## AMENDMENT #2 TO WAYNE COMMUNITY SCHOOLS – WAYNE STATE COLLEGE INTERLOCAL AGREEMENT FOR FACILITIES USE

This Amendment #2 to the Interlocal Agreement for Facilities Use is made and entered into by and between Wayne Community School District 90-0017, also known as Wayne Community Schools, hereinafter referred to as "School," and the Board of Trustees of the Nebraska State Colleges doing business as Wayne State College, hereinafter referred to as "College."

The School and the College are parties to that certain Interlocal Agreement for Facilities Use dated September 15<sup>th</sup>, 2018, hereinafter referred to as "Agreement", Amendment #1 executed 9/15/2021, and now wish to further amend Section 1, of the Agreement to read as follows:

- 1. Section 1. Duration of the Agreement shall be deleted in its entirety and replaced with the following:
  - 1. **Duration**: This Agreement shall commence on September 15, 2018 and continue until August 1, 2023 unless terminated by the Parties as hereinafter set forth.

The Agreement shall be modified as stated above and the remaining terms contained in the Agreement dated September 15<sup>th</sup>, 2018 inclusive of Amendment #1 shall remain in full force and effect.
