Priority Initiative Examples

- **Business process analysis to maximize collaboration and automation**

 - Partner with the campuses earlier in the process of purchasing technology
 - IT service catalog/inventory
 - Create technology groups across the campuses
- **Knowledge continuity/succession planning**
 - Documentation
 - Cross-training
