CHANCELLOR INFORMATIONAL ITEMS

INFORMATION ONLY: Remission Fund Award Report by Category

In accordance with the Board's Tuition Remissions Policy 3400, the Colleges have provided a summary of the remission funds awarded by category. Remissions are permitted by the state, allowing the NSCS to collect either no tuition or reduced tuition from students meeting specific criteria that are approved by the Board. The categories approved by the Board are spelled out in Board Policy 3400.

The first page of the attachment contains a summary by category of tuition remission awards for the entire System, comparing FY2020-21 to FY2021-22. The following pages break those remissions out by each College, continuing the comparison to the prior year. The "Other Discretionary Waivers" offered by the colleges are broken out into more detail on the final page of the report.

A revision to Policy 3400 was approved by the Board in September 2019, to allow the Colleges greater flexibility in allocating the tuition remissions, beginning for FY2019-20. The revisions also noted that beginning in FY2019-20 total remissions for all categories/programs generally shall not exceed twenty-two percent (22%) of the College's four (4) year average gross tuition, unless an exception is approved by the Chancellor.

Historically, the annual tuition remission percentages are as follows:

A remission bank was created to allow institutions the capacity to draw upon unused remissions from the previous four (4) years. The bank is a rolling average of the past four (4) years. The remission banks reflect the four (4) year average amount the Colleges are over or under the established 22% limits. The following table shows the status of the remission banks for the past four (4) years. The bank for CSC and PSC is negative and WSC has a positive cushion.
