ACTION: Approve FY24 Food Service Contract Amendments

Board Policy 9015 addresses food service contracts. If the food service operation is to be outsourced, contracts are to be solicited every five years and approved by the Board. The annual renewals and contract amendments (or addendums) are approved by the Board. The Colleges are requesting approval of the contract amendments for FY24.

Chadron State College's food service operations is under contract with Aladdin Food Management Services, LLC. The contract term is July 1, 2019 through June 30, 2024.

Peru State College's food service operation is under contract with Fresh Ideas Management LLC. The contract term is July 1, 2019 through June 30, 2024.

Wayne State College's food service operations is under contract with Compass Group USA, Inc. The contract term is July 1, 2019 through June 30, 2024.

The approval of the contract amendments foreshadow the likely increases we will see for board rates when we approve rates in April. There are a number of factors that are driving up the contract (agreement) costs for food service. The difficulty in hiring workers and the pressure on wages for most service positions, as well as substantial increases in food costs are major factors. The 12-month CPI for the all items index ending November 2022, rose 7.1%, and food away from home rose 8.5%.

The food service cost increases proposed are within the contract term limits and the related caps on increases.

Chadron State College

Chadron State is requesting the extension of their food service agreement with Aladdin Food Management Services, LLC, for the period of July 1, 2023 through June 30, 2024. There is no increase in the management fee over the FY23 contract; the management fee is \$128,873. CSC assumes all cost increases under their current agreement for labor and food costs. CSC will be assessing the impact of the current rise in food costs, labor and other operating costs when determining their food service increase to students for the coming year.

Peru State College

Peru State is requesting approval of an amendment to their agreement with Fresh Ideas for the period of July 1, 2023 through June 30, 2024. The agreement provides for a payment to

the vendor based on a per meal sliding/scale. It also provides that "Fresh Ideas will limit all annual rate increases to 5% per year or the Consumer Price Index, whichever is less." The amendment provides for a 5% increase across the scale for all board meal reimbursement rates.

Wayne State College

Wayne State requests approval for an amendment to their agreement with Compass Group USA (Chartwells) for the period of July 1, 2023 through June 30, 2024. The agreement provides that Compass Group will receive revenues based on a per meal reimbursement rate. The costs for all meals under the amendment are increasing 8.0% in the amendment, including meals for guests and employees. The CPI is used as a guide but does not cap the rate increases.

The System Office recommends approval of the FY24 Food Service Contract Amendments.

AMENDMENT NUMBER SIX TO FOOD SERVICES AGREEMENT

This Amendment Number Six to Food Services Agreement is made as of January 13, 2023, between the Board of Trustees of the Nebraska State Colleges doing business as Wayne State College, with principal offices located at 1111 Main Street, Wayne, Nebraska 68787 ("College") and Compass Group USA, Inc., a Delaware corporation, with principal offices at 2400 Yorkmont Road, Charlotte, North Carolina 28217, by and through its Chartwells Division ("Chartwells") (collectively the "Parties").

WHEREAS, College and Chartwells are parties to that certain Food Services Agreement dated March 22, 2019, as amended by that certain Amendment Number One to Agreement executed by College on January 14, 2020, by that certain Amendment Number Two to Agreement executed by College on June 10, 2020, by that certain Amendment Number Three to Agreement executed by College on January 18, 2021, by that certain Amendment Number Four to Agreement executed by College on January 13, 2022, and by that certain Amendment Number Five to Agreement executed by College on June 19, 2022 (collectively, the "Agreement");

In consideration of the promises contained herein and for other good and valuable consideration, the Parties agree as follows:

- 1. <u>Definitions</u>. All capitalized terms not otherwise defined herein shall have the meaning ascribed to them in the Agreement.
- 2. <u>Amendment of Exhibit A, Section B</u>. Effective July 1, 2023, Exhibit A, Section B of the Agreement is deleted in its entirety and replaced with the following:

B. Meal Plans, Casual Meal Rates, Conference Rates and Catering Guide

The number of Board plan days per academic year will be two hundred twenty-five (225). The specific allocation of days will be mutually agreed upon prior to the beginning of each academic year.

The following meal plans shall be established for the 2023-24 academic year. College shall pay Chartwells the 'Per Potential Meal Rate Including DB' for each meal participant:

The Parties hereby confirm and ratify the original Agreement, Amendment Number One, Amendment Number Two, Amendment Number Three, Amendment Number Four, and Amendment Number Five in conjunction with adopting this Amendment Number Six. The Agreement, as amended hereby, constitutes the entire agreement between the parties and their predecessors pertaining to the subject matter of the Agreement, as so amended, and supersedes all prior and contemporaneous agreements and understandings of the parties and their predecessors in connection therewith.
