INFORMATION ONLY: 2023-2025 NSCS Biennium Appropriations Summary

The 108th Legislative Session adjourned June 1, SINE DIE. All bills dealing with higher education funding have been passed onto the Governor and signed.

Legislative Bill 814 is the State Government appropriations bill for the biennium ending June 30, 2025. An additional bill LB705A also included funding of \$4,984 to support application changes. These bills have been signed by the Governor. A summary of the items funded is attached.

The total increase to base operating funds for FY24 is 6.56%, or \$3,952,436. When including the State Aid funding increase of \$1,357,500 the increase is 8.38%.

The total increase to base operating funds for FY25 is 5.76%, or \$3,703,226. When including the State Aid funding increase of \$432,500 the increase is 6.02%

It should be noted that the funding summary does not include the PSC - Corrections Workforce Development Pathways (CWDP) Program. The funding is provided to the Corrections department with the biennium funding retained at \$973,465, with \$675,000 of that amount available to support 45 for scholarships.

LB818 included the transfer of \$3.0M to the Board's Risk Loss Trust Fund. We understand that the money will be received in early FY24 and can then be used to manage insurance losses, deductibles, and hopefully slow down premium increases.

Additional funding for the Geothermal Utilities Project at PSC in FY24 is \$2,101,905. This is reaffirmation funding found in LB383 (2021).
