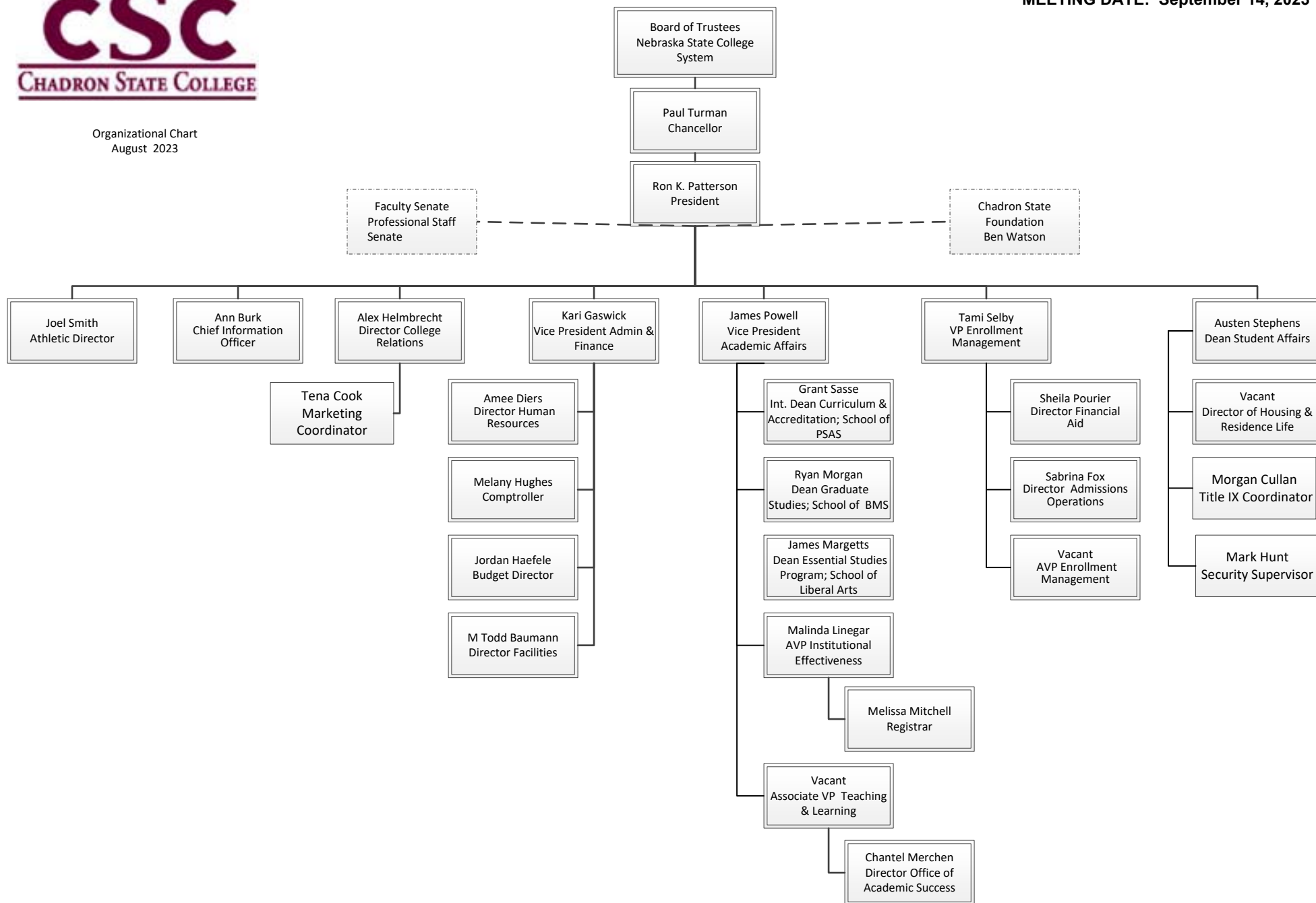

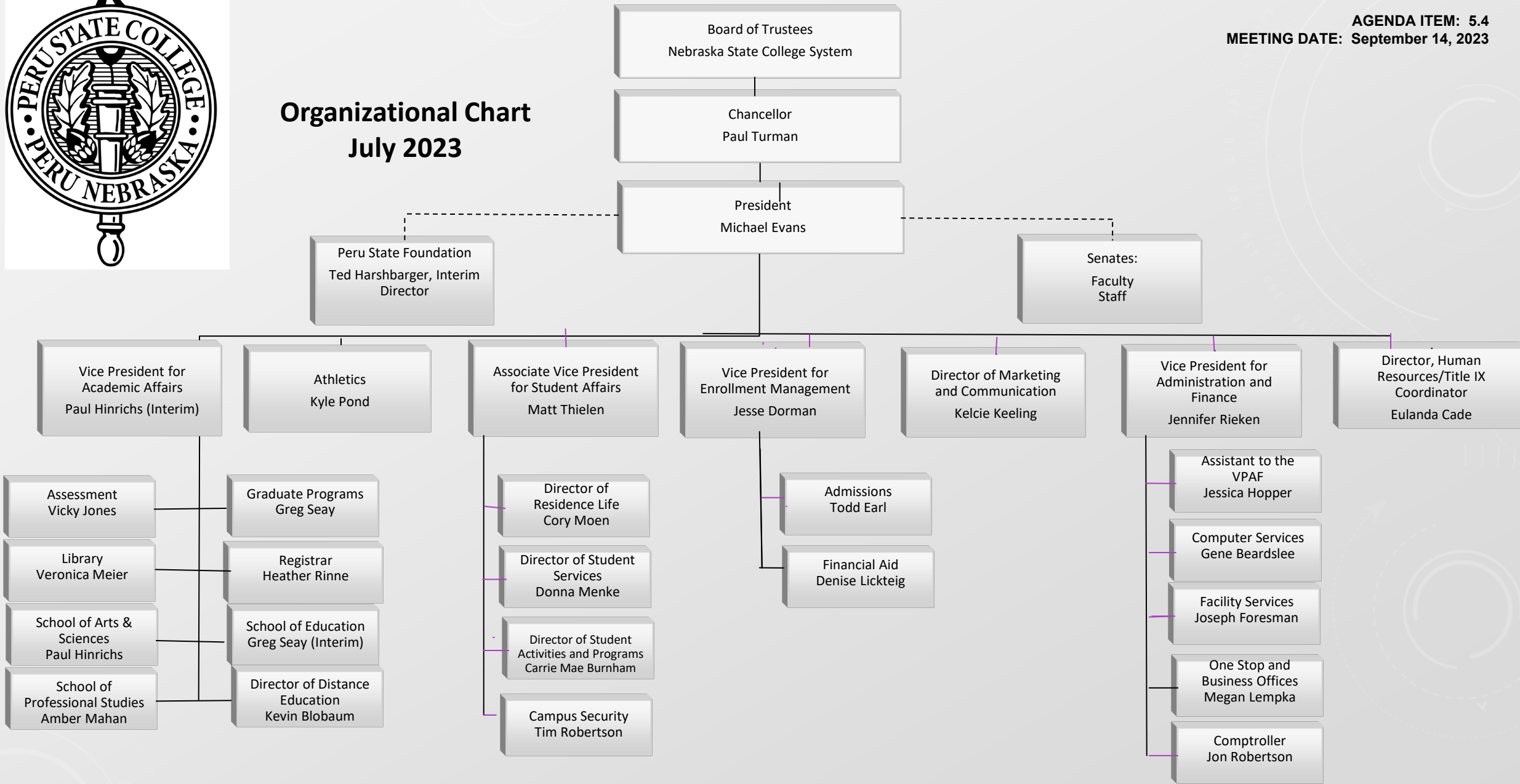


Organizational Chart
